FEES: A \$30 (plus HST) family registration fee is due upon registration and is non-refundable and non-transferable. Upon registration, tuition payment for the first month (September) and the \$30 (+hst) registration fee is due in full. (Registration will only be accepted with Payment).

NEW SEASON 8 : FAMILY PAYMENT FORM IS TO BE COMPLETED and SIGNED. ALL FEES ARE DUE AS PER SIGNED FORM. Classes start mid September to mid June. Tuition is a set amount depending on the length of class.

Any fees submitted AFTER THE 15th OF THE MONTH will be subject to a non-negotiable \$15.00 late fee. There are absolutely no refunds or transfers on any funds paid to Infinity Dance Inc., this includes tuition payments, costumes, merchandise including retail items and dancewear sold at Infinity Dance Inc. Payments may be made by cash, cheque, debit, Visa and Master Card. All payments made by cheque which are returned due to nonsufficient funds (NSF) will be assessed a \$30.00 administrative fee in addition to the amount outstanding, *and will disallow further cheques from being accepted as payment.* **ALL outstanding fees (costume balance, etc.) must be paid in order to participate in the year-end recital.**

CANCELLATION: Infinity Dance Inc. reserves the right to cancel any class temporarily or permanently without advance notice due to inclement weather, hazardous driving conditions, emergencies or lack of students. We will communicate all studio closures via social media and email, when in doubt call ahead or check our website www.infinitydance.ca. Classes with fewer than 5 students may be combined and/or moved to a different time slot in order to be eligible for the year-end shows. Classes with fewer than 4 students by November 1st will be closed.

ATTENDANCE AND MAKE-UP CLASSES: Please be on time for class with your proper dancewear and shoes for all classes. Proper attire is listed on the studio website. An important part of dance training is the discipline learned from arriving to class on time and with proper hair and attire. Regular attendance is essential for student success. **There will be no refunds given for missed classes for any reason.** Dancers are encouraged to make-up missed classes in another level or style. Talk to your teacher for a recommended make-up class. Repeated absences may mean that a dancer is removed from sections of class choreography or will not be allowed to perform with the class.

COSTUMES: For students performing in our optional year-end shows, a costume down payment of \$60 (+ tax) per class is due NOVEMBER 1st. **ALL COSTUME DOWNPAYMENTS ARE NON-REFUNDABLE AND NON-TRANSFERABLE.** The remaining balance is due APRIL upon receipt of the costumes.
